Ensuring good governance and sustainability is considered an enabler to meeting strategic objects. Oceana is committed to the Sustainable Development Goals (SDGs) and promotes the efficient use of resources and integration of sustainability practices into all Oceana operations. Mitigating our environmental impact is an important aspect of the Oceana Group's commitment to continual improvement and sustainability. This Environmental Policy is applicable to all activities, products and services of all land-based and sea-based facilities over which the Oceana Group has operational control.

PURPOSE

The purpose of this policy is to ensure good stewardship of natural resources and the mitigation of any impacts on the environment due to operational activities.

SCOPE

This Policy is applicable to all staff, visitors, contractors, activities, products and services of all land-based and sea-based facilities over which the Oceana Group has operational control.

POLICY STATEMENT

The Oceana Group's Environmental Policy is governed by the following principles:

- Sustainable and efficient use of natural resources, in particular marine living resources.
- A precautionary approach to environmental challenges and impacts.

The Environmental Policy is further guided by its commitment to the United Nations Global Compact to undertake initiatives to promote greater environmental responsibility and to encourage the development and diffusion of environmentally friendly technologies.

The Oceana Group's environmental policy, applicable to all operations, activities, products and services seeks to:

- Ensure responsible harvesting and procuring of marine resources in a sustainable manner whilst reflecting national and or international policies, regulations and targets.
- Implementation of effective waste management to reduce input costs, lower the cost of waste disposal and improve our standing as a good corporate citizen.
- Promote responsible water use throughout our operations and encourage our suppliers and stakeholders of the same.
- Meet or exceed the requirements of applicable environmental laws and regulations. Align our environmental strategy to environmental best practise as well as industry standards in all our business operations.
- Recognise the environmental risks associated with the modification of gene structures and the possible biodiversity impact of such modification. Manage the use of GMO in the supply chain.
- Reflect globally applicable and modern corporate operating standards and strive towards obtaining globally applicable product certification. Set quantifiable objectives and targets for all key areas.
- Improve research and disseminate knowledge on the fishing industry.
- Promote an awareness of global warming and its effects amongst stakeholders (incl employees and suppliers) and the public at large.
- Provide our consumers, customers, employees, communities, public interest groups and the public at large with relevant and appropriate factual information about the environmental impact of Oceana's products, packaging and operations.
- To further promote, create awareness and monitor sustainability practices across the supply chain and to support an ecosystem
 approach to fisheries management. In support of the commitment, we've included in the supplier code of conduct a supplier
 commitment that addresses
 - o energy use and greenhouse gas emissions;
 - o water use and biodiversity impacts;
 - o human rights;
 - o environmental issues and pollution; and
 - o waste and resource use.
- Recognise the impact our activities may have on the environment (including Climate Change) and implement initiatives to reduce the energy intensity of our operations.
- Encourage the development and diffusion of environmentally friendly technologies.
- Continually assess our environmental technology and programs and monitor progress towards environmental goals.
- Ensure every employee understands and is responsible for incorporating environmental quality and management practices in their daily business activities. This is best done by adhering to applicable operating policies and programs and in using available resources to implement Oceana's Environmental Policy.
- The continual improvement in the environmental performance of our activities, products and services. The prevention of polluting activities through adherence to the Oceana Environmental Control System, an ISO 14001 standard compliant system.
